New section page explaining the need for reasonable excuse for leaving home to go to work and providing example scenarios for where it might be allowed.

Paragraphs 13.1.3 to 13.1.5 moved to section 13.2

Paragraph 13.2.3

New emphasis on legal grounds for client attendance. i.e. only being allowed if remote working is not a viable option

Consider whether it is appropriate for creative operators and clients to be working in same room together for long periods. Added recommendation for face coverings.

Strengthened need for good ventilation in suites and repeated recommendation for the use of air quality meters to verify effectiveness of ventilation strategy.

Only essential persons should be in an edit suite and only for the minimum possible time.
